Oak Habitat & Presribed Fire Project Tour

Thursday, July 13, 6 - 8:30 p.m.

We are thrilled for the opportunity to showcase an extensive oak habitat restoration project during a summer evening tour on July 13. Four adjacent neighbors in the "Greenhill" area off of Crow Road have been cooperatively working alongside LTWC, the Confederated Tribes of Grand Ronde, Ecostudies Institute, and other partners to restore over 300 acres of habitat through a combination of thinning encroaching woody plants and the use of prescribed fire and cultural burning. This project represents a history of relationship-



building, grant writing, and the vision of neighbors to restore a large area of upland habitat. All four families are hosting this event and will lead various parts of this tour and share with you the work that has been done and what remains to complete the project. You'll also hear from restoration practitioners on the techniques to restoration at the site, the use of prescribed fire, and how these crucial habitats co-evolved with the use of fire for thousands of years alongside the Kalapuya people.

This evening walk will have two options: a longer, approximately 1.5 mile walk, and a shorter walk less than a mile. You can participate in the tour of your choice. **We're asking attendees to RSVP online at longtom.org/oaktour2023 by July 5. We'll respond with more details and directions.** Your RSVP helps us plan for the necessary arrangements. Snacks and water will be provided, and there will be a portable restroom. URBAN RAIN GARDEN PROJECT COMPLETED!

Construction and landscaping of the Willamette Christian Center Trout Friendly Landscapes project is complete! LTWC's Urban Waters & Wildlife Program team designed a series of four large, linear rain gardens in WCC's parking lot adjacent to West 18th Avenue before overseeing construction this last winter and spring. Upward Landscape Solutions was contracted to remove nearly 12,000 square feet of asphalt and subgrade for the rain gardens that are now able to treat rainfall landing on the parking area.





Rain gardens like these clean, cool, and slow down stormwater before it reaches

storm drains and enters our local waterways. Vegetation in rain gardens provides an important filtering mechanism for pollutants such as petrochemicals and heavy metals from vehicles. A mixture of canopy trees, understory shrubs, and ground cover plants were installed over approximately half of an acre total. These plants provide a diverse habitat structure for wildlife and pollinators while also maintaining pedestrian safety and meeting the goals WCC has for the property. An array of funding partners made this project possible, including a grant from the Oregon Watershed Enhancement Board, City of Eugene, Oregon Department of Environmental Quality, community donations, planting funds from faith-based organizations, and significant match from WCC. GRANT AWARDED TO EXPLORE TARGETED GRAZING AS A TOOL FOR OAK AND PRAIRIE HABITAT

We're excited to announce that LTWC was awarded a federal grant from the U.S. Department of Agriculture that will fund a project aimed at researching the potential to expand the use of small livestock like goats and sheep to control woody brush in prairie-oak habitats. These rare ecosystems evolved with regular disturbance, such as from low-intensity and high frequency burning by the Indigenous Kalapuya people. Without disturbance, brush can quickly become overgrown and suppress native plant communities, restrict habitat for wildlife, and add fuel that increases wildfire risk. Depending on the numerous factors, including the property owner's preferences, some management techniques may not





always be cost effective or practical, and targeted grazing could provide a helpful alternative in the right situations.

With coordination from LTWC, particularly Uplands Program Manger Abby Colehour (pictured above), the project will spotlight emerging efforts to apply prescribed grazing as a tool for oak-prairie habitat management. Targeted grazing demonstrations are planned at three restoration sites with strategic seasonal timing for two years, and will include vegetation monitoring before and after grazing. Results will be shared with regional restoration practitioners, along with implementation best practices and cost considerations. In addition to the USDA, project partners include OSU Extension, Confederated Tribes of Grand Ronde, City of Eugene, and grazing contractors Bad Ass Hooves and Results Partners, LLC. We're eager to explore the benefits of another restoration technique in our toolbelt!

STOP BY OUR BOOTH AT THE MONROE FESTIVAL!

The City of Monroe is hosting their third annual Monroe Festival on Saturday, June 24th from 10 a.m. to 6 p.m. Come support this rural hub in the northern part of our watershed for a day of live music, craft goods, wines and brews, food, and fun! LAND ACKNOWLEDGEMENT

The Long Tom Watershed lies within the traditional homelands of the Tribes and Bands of the Kalapuyan peoples. Following treaties in the 1850s, the Kalapuya people were dispossessed of and forcibly removed from their Indigenous homeland by the United States government. Today, many descendants are citizens of the Confederated Tribes of the Grand Ronde Community and the Confederated Tribes of Siletz Indians. We acknowledge that we are on occupied lands, and express our respect for Kalapuya and all Tribal Nations of Oregon, and the important contributions they continue to make to their communities, including to the stewardship of this watershed.
